- Official transcript
- Letter of recommendation from his/her work-based learning employer/supervisor
- Photo Release with Parent signatures for approval to use student photo and name on MCPA website (listed on the application).

All of the above information should be submitted to your *MCPA Regional Representative* by Tuesday March 12, 2024. Each region will pick up to three applicants to submit to the MCPA Executive Board; one from each of the categories listed below. This year, the MCPA Executive Board will award a total of three, \$1,000 Scholarships in the following categories:

- > One, \$1,000.00 Scholarship for a Non-C.T.E. Work-Based Learning Placement
- > One, \$1,000.00 Scholarship for a Special Education/Transition Work-Based Learning Placement
